Clinical dermatological tests have been conducted to assess the skin compatibility of the product using voluntary test persons in enclosed and repeat application models. ### COMPATIBILITY TESTS

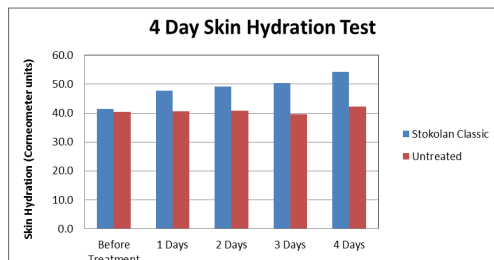
#### Rubber Production Process Compatibility

In testing conducted by the Deutsches Institut für Kautschuktechnologie (DIK) in accordance with DIN EN ISO/IEC 17025, the use of Stokolan® Classic in rubber production process does not influence the cohesive strength of rubber.

### EFFICACY TESTS

#### Skin Hydration Test

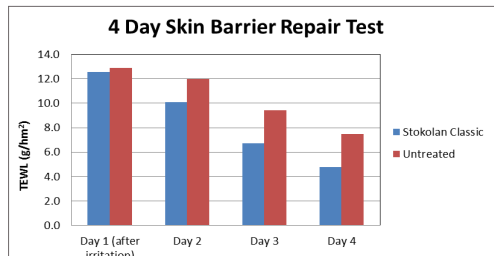
The moisturising properties of Stokolan® Classic were assessed via application of the product twice daily at an interval of approx. 5 hours to the forearm skin of healthy volunteers over a 4 day test period. The starting values for the skin moisture were determined in the morning by means of the Corneometer® and before the first application and then again on the morning of the subsequent day.



Results show that under repeated usage conditions, Stokolan® Classic provides a continuous increase in the hydration of the skin by 31.7% over untreated skin. This demonstrates that the skin moisture is clearly improved by Stokolan® Classic when used regularly.

#### Skin Repairing Test

Skin regeneration testing was performed on the forearm skin of healthy volunteers. Skin damage was induced by occlusive application of 0.5% sodium lauryl sulphate solution over a 12 hour period. The initial damage of the skin was classified by means of two parameters: a) visual inspection (irritation score according to Frosch and Kligman) and b) trans-epidermal water loss (TEWL as an indicator of the skin barrier quality). Stokolan® Classic was then applied twice daily at an interval of approx. 5-6 hours over a 4 day test period.



Results show that under repeated usage conditions, both the visually apparent damage and the barrier damage characterised by the TEWL is reduced compared to untreated skin. This demonstrates that the skin condition and barrier function is repaired by Stokolon® Classic when used regularly.
