Additives are cleared according to FDA 21 CFR Part 178 (Indirect food additives), are generally recognised as safe (GRAS), are prior-sanctioned food ingredients, or are cleared on basis of regulations for food additives of before 1958.</p> <p>The polypropylene complies with FDA 21 CFR 177.1520 "olefin polymers".</p> <p>The pigments in the masterbatch are listed under FDA 21 CFR 178.3297 „Colorants for Polymers“.</p>

**General**
